Short term plan is to repair bad places on road with gravel from county. Forest service has some money in a fund to buy the gravel and we can contribute manpower. Long term plan is to work out an agreement with Forest Service, Gunnison County and AIA contributing. Arrowhead Owners are the major users of Alpine Road. A mobile rock crusher may be considered for use upcountry while timber sale is ongoing.

NNTC:

NNTC and CenturyLink have finally come to terms on the Internet service. Connection between CenturyLink's fiber optic and Nucla's line at the telephone boxes on the Alpine will occur soon.
